College for the requirements of students' interest and benefits wants to add different digital platform for new education system for. These include TCS ion digital classroom (tied up with BITT and TCS), and TheOs System (ERP of the College in which the digital classroom program is included) online classrooms, guest lectures by other colleges experts, YouTube online classes, AICTE free courses and faculty online classes so that not a single student may suffer by this pandemic in terms of loss of studies, it is advised to the students that the college will run the online classes for next semester (after having the guideline of Academic Council) as per the schedule received from the JUT, all the students are required to complete the ERP registration so that college have all the information of the students email id and phone number.
