

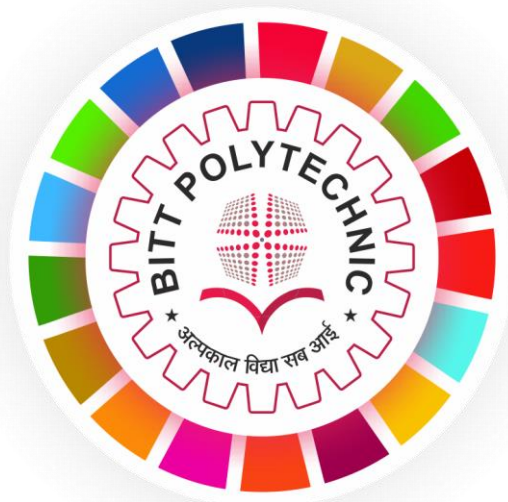

### **GENERAL INSTRUCTIONS:**
