

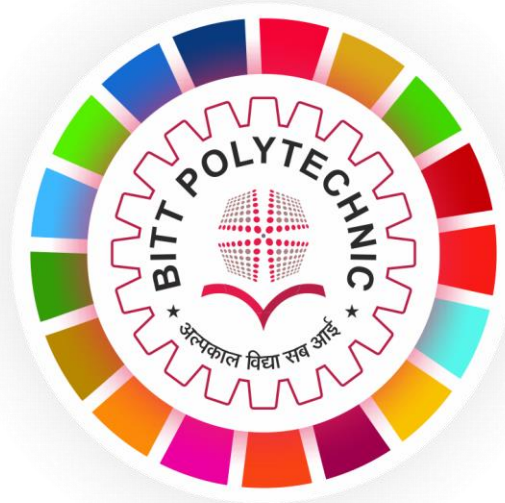
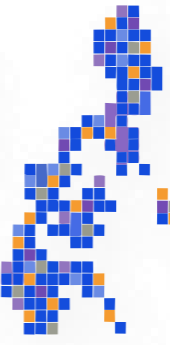

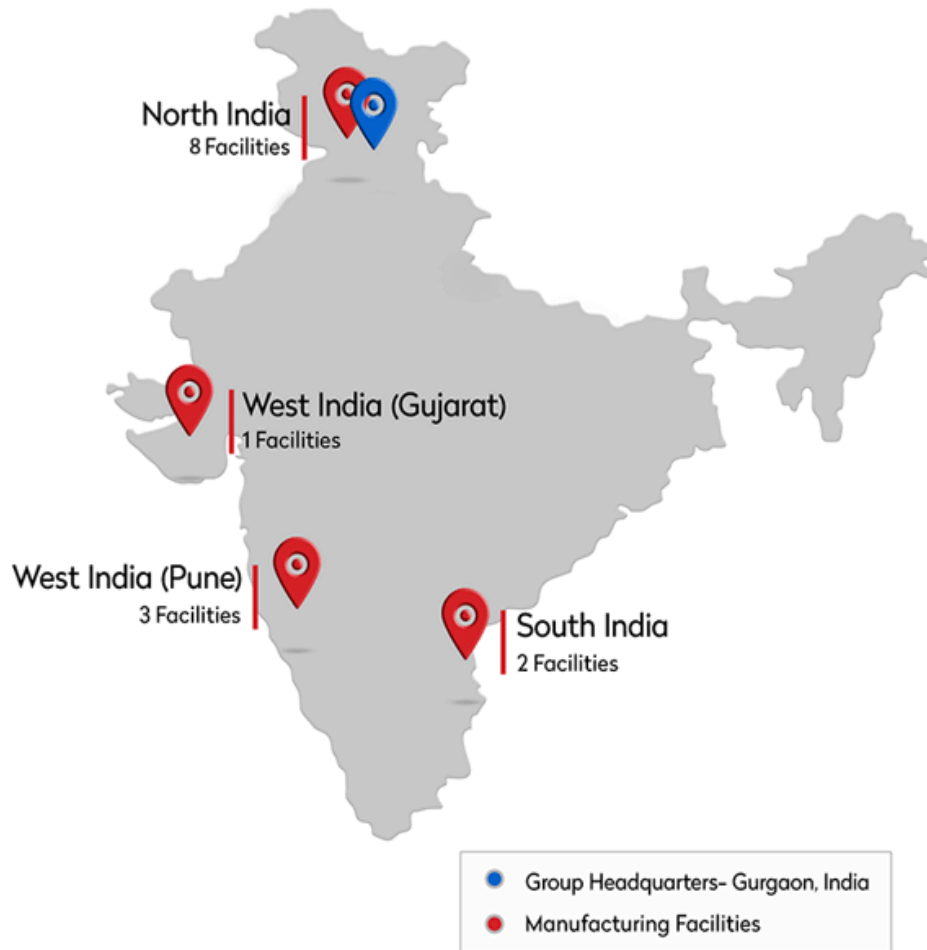

Employment Cycle and Management of OETs

- All OETs will be on company rolls and eligible for all the benefits as per company policy
- OETs will be hiring initially for three years of tenure with the organization.
- On joining, OETs will be given one-month structured Induction training to cover the functional aspect
- After one month of structured training program OETs will be assigned their responsibilities.
