Information regarding Post – Matric Scholarship scheme for all scheduled caste, scheduled tribe & backward cast students studying in diploma course in the financial year 2022 -23

It is hereby informed to all scheduled caste, scheduled tribe & backward cast students studying in diploma course in the financial year 2022 -23 that an application form is invited under the scheme of post matric scholarship as per instruction by the government of Jharkhand and their set parameter is given below:

1. Criteria of income for scholarship

Yearly family income should not be greater than from 2.50 lakh and students receiving scholarship under this scheme will not be able to avail any other scholarship.

2. Process of application

Qualified students have to apply online by the following all the guidelines and process given in the website https://ekalyan.cgg.gov.in, and scan copy of (in jpeg/jpg, upto 1mb) all following documents will be upload on website.

- (i) Original copy of income certificate issue through online (issue by Circle officer/sub Divisional Officer & Deputy Commissioner)

 The income certificate issued after the date of 1.09.2022 will be valid.
- (ii) Original copy of caste certificate issue through online (issue by Circle officer/Block Development Officer/sub Divisional Officer & Deputy Commissioner)
- (iii) Original copy of residensial certificate issue through online (issue by Circle officer/Block Development Officer/sub Divisional Officer & Deputy Commissioner)
- (iv) Original copy of current year bonafide certificate with fee structure on the letter head of institute.
- (v) Attested copy of previous exam marksheet.
- (vi) The amount of scholarship will be transferred to the account of eligible students through Aadhar Enabled DBT through PFMS. (Seeding of Bank account with Aadhaar number is mandatory)



Step for issue Bonafide certificate with fee structure on the letter head of institute.

- Step -1. Students need to get a no dues receipt from fee deposite counter.
- **Step 2.** Write an application for issue bonafide certificate in suitable format and submit it along with not dues receipt at Reception -2.
- Step 3. After 3 working days you may collect your bonafide certificate from
 Reception 2 and 1st semester regular & Lateral entry students may collect bonafide certificate from admission department.
